Statement Concerning REACH and Substances of Very High Concern

Many of TOTAL PETROCHEMICALS USA, INC.'s polystyrene customers outside of Europe manufacture articles, which in most cases will not require registration or notification under REACH to be imported into Europe. Article 7 of REACH, defines circumstances under which article producers and importers are required to register or notify of substances in articles and details the requirements. Along with other requirements, Article 7 requires that any producer or importer of articles to notify the European Chemical Agency when an article contains Substances of Very High Concern (SVHC) in a concentration above 0.1 % (w/w).

At this point in time, TOTAL PETROCHEMICALS USA, INC.'s polystyrenes do not contain any substances specifically identified as SVHCs* at levels greater than 0.1 % (w/w), including the following substances from the candidate list for Annex XV, as updated on Oct 29, 2008.

Based on information from our suppliers and knowledge of our process, we believe that our products do not contain these SVHCs in amounts greater than 0.1 %.
